The 3M™ E-A-Rsoft™ 21 Earplugs are disposable and designed for insertion into the ear canal to help reduce exposure to hazardous levels of noise and loud sound.

These earplugs seal the entrance part of the ear canal and may be used for protection against low to moderate noise environments, providing effective protection across all test frequencies. The 3M™ E-A-Rsoft™ 21 earplugs are available as an uncorded model only.

SNR = Single Number Rating (the value that is subtracted from the measured C-weighted sound pressure level, L_C in order to estimate the effective A-weighted sound pressure level inside the ear)
