Usage Details

It is recommended to wash the car regularly. Automated car wash (without hot wax) is recommended to remove light dirt. Contaminants on surface areas can be cleaned by using the 3M Cleaner for Matte Wrap Films.

Put some of the cleaner on a lint-free cloth and remove the contaminant with circular movements. The use of 3M™ Scotch-Brite™ High Performance Cloth 2010 is recommended.

In case of difficult contaminants (e.g. rain water spotting) use a sponge as Scotch-Brite® Easy Eraser EE2, Scotch-Brite™ Easy Eraser 831/2 or Scotch-Brite® Easy Eraser Pad some cleaner onto the sponge and use slight pressure to remove the contaminant. Excessive pressure might create scratches on the film surface.

After cleaning the surface with 3M Cleaner for Matte Wrap Films, wipe cleaned areas with water-soaked cloth. This is to remove the cleaner contaminated with dirt from the film surface.

Dry the film using a clean soft cloth.

Shelf Life and Storage

The shelf life as defined below remains an indicative and maximum data, subject to many external and non-controllable factors. It may never be interpreted as warranty.

The shelf life is never more than 10 years from the date of manufacture on the original sealed container. Use within 2 years after opening the container.

Storage conditions: +10°C to +30°C, out of sunlight, original container in clean and dry area.
