This puts hearing protection in the same level of high risk categorization as respiratory protection and fall protection.



How will this change of categorization affect you?

Your supplier of hearing protection products

Manufacturers of hearing protection products will be subject to more stringent on-going quality control procedures, including quality control of products or quality assurance for the entire manufacturing site. In addition, new CE marking will be applied on all packaging and products (where feasible).

Your users of hearing protection products

Protection from harmful noise needs to be taken seriously, and using the right product and wearing it correctly is vital. The new Regulation recognises this and will bring added confidence to users that the products they are wearing are able to provide reassured protection.

As Safety Officer what do you need to do?

- You will need to make sure you're buying hearing protection from a manufacturer that complies with the new Regulation when it becomes mandatory after 2019.
- Training of workers in the correct selection of personal protective equipment is already an essential requirement under the PPE User Directive 89/656/EEC.

What happens and by when

March 2016

- New Regulation published in the Official European Journal and adopted by member bodies
- Test houses, Notified Bodies and Manufacturers to start becoming familiar with the new Regulation

March 2018 (transition period)

 Both the products meeting the old PPE Directive and the new PPE Regulation can be placed on the market
