- The 3M™ C. Diff Solution tablets' NaDCC (Sodium Dichloroisocyanuarate) chemistry and bleach (Sodium Hypochlorite) are different chemistries. When diluted properly with water, NaDCC doesn't generate the chemical byproduct Sodium Hydroxide, which is a caustic compound that is a byproduct of bleach. This is one of the delineations between the two chemistries.

- ▶ pH of 5.5 to 6.5 is closer to neutral opposed to typical bleach options.
