New Primed Bumper Prep		
1		<p>Cleaning</p> <p>Clean part with soap and water, followed by a VOC compliant surface cleaner.</p>
2_A		<p>Surface Prep Hand</p> <p>Sand edges and other hard to reach areas using P400 flexible abrasive sheet until the surface is matte and all sheen has been removed.</p>
2_B		<p>Surface Prep Machine</p> <p>Sand remaining surfaces using P400 flexible abrasives on an orbital sander until the surface is matte and all sheen has been removed.</p>
3		<p>Re-clean</p> <p>Clean bumper surface with soap and water, followed by a VOC compliant surface cleaner.</p>
4		<p>Apply Top Coats</p> <p>Seal and paint bumper following paint company recommendations.</p>
