

Process: Product and Order Numbering Details

3M ID	11-digit numeric	10-digit random numeric – both the 11-digit and 10-digit 3M ID will be referenced during the transition. Customers may continue to use the 11-digit 3M ID, UPC, 3M Catalog Number and/or Customer Part Number.
Invoice Number	7-digit alphanumeric (AB12345) included on most order and shipping documents. Number is sequential for related shipments and prefix is significant to designate most manufacturing sites.	10-digit numeric (9234567891) randomly assigned, non-sequential. Billing documents such as the invoice, debit memo and credit memo begin with "9". Invoice number will no longer appear on order documents or shipping documents.
3M Order Number	Does not exist	10-digit numeric (4234567891) beginning with "4" referenced on most documents associated with a 3M order.
3M Delivery Number	Does not exist	No immediate impact for SPSD products. 10-digit numeric (8234567891) beginning with "8" assigned to orders processed for shipping from deployed sites. If shipped from non-deployed sites, the format is 7-digit alphanumeric (AB12345). The Delivery Number is used similarly to the former 3M Invoice Number.
Shipment Number	Does not exist	No immediate impact for SPSD products. 10-digit numeric (1234567891) assigned at shipping from a deployed site. If shipped from a distribution center (DC) or non-deployed manufacturing site, the format is 10-digit alphanumeric (ABCD123456). Multiple Delivery Numbers can be associated with one Shipment Number.
Ship Reference Number	Does not exist Reserved. 3M Confidential.	No immediate impact for SPSD products. 10-digit numeric (8234567891) beginning with "8" if shipped from deployed sites, which will match the Delivery Number on other documents. If shipped from non-deployed sites the format will show 7-digit alphanumeric (AB12345) that corresponds to the former 3M invoice number.

Order Quantity Unit

• **Future:** Nomenclature for some units of measure may appear differently depending on order placement method, for example electronic, fax, etc. Customers can continue to use existing format.

Customer Requested Date

- Current: Deliver By or Deliver On date if requested by the customer
- **Future:** Estimated delivery date if requested by the customer. If customer provides requested ship date it will be used as requested delivery date. If customer doesn't provide a date, date is order processing date.

Delivery Date

- Current: Does not exist
