

**3M™ SAFETY GEAR GIVEAWAY 2018**  
**OFFICIAL RULES**  
**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN**  
**A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING**

**ELIGIBILITY:** The 3M™ Safety Gear Giveaway (the “Sweepstakes”) is only open to legal residents of the 50 United States and the District of Columbia who are at least 18 years old as of the date of entry (except residents of AL and NE who must be at least 19 years old and residents of MS who must be at least 21 years old as of the date of entry).
