Unique abrasive and construction scuffs the surface to create optimal bonding of the finish and conform to uneven surfaces.

- Designed to remove soiled top layers of floor finish using water or neutral cleaner instead of harsh stripping chemicals
- For use on standard, low-speed (150 400 RPM) automatic scrubbers and rotary machines

Application

This product is for use with neutral cleaner or water to remove layers of soiled or damaged floor finish without the slippery surface and harsh chemicals associated with standard floor strippers.

For use on finish-coated flooring such as wood, sheet vinyl, vinyl tile, marble, terrazzo, or concrete.

Special Features

- Specialized manufacturing process reduces the number of knots and clumps, which eliminates scratching of floors while providing greater consistency and extended pad life.
- Pad will not be significantly affected by water, detergents, or cleaners normally used for floor maintenance.
- Unique design reduces clogging during use.
- Scotch-Brite™ Surface Preparation Pad Plus does not require the use of a backer pad.
- Exacting standards for quality mean thickness uniformity from edge to edge and pad to pad is exceptional, resulting in consistent performance without pad wobble or machine vibration. The precise center-hole placement and roundness of the pads also contribute to the smooth operation, which extends pad life and may help reduce operator fatigue.

Directions for Use

- 1. Dust mop the entire floor prior to scrubbing.
- Install an appropriately sized Scotch-Brite[™] Surface Preparation Pad Plus on cleaning equipment.
 Scotch-Brite[™] Surface Preparation Pad Plus can be used on automatic scrubbers, rotary floor machines without a backer floor pad.
- 3. Wet the floor with water or neutral cleaner and scrub the floor to the desired result.
- 4. Both sides of the pad can be used.
- 5. When desired, the pad can be flipped.
- 6. Pick up dirty solution with a mop, wet vacuum, or automatic scrubber.
- 7. Rinse the floor and let it dry prior to recoating or opening to traffic.
- 8. Pads may be rinsed with water to clean if desired.

Maintenance and Cleaning

- Remove the floor pad from the machine after each use
- Wash and rinse under tap water
- Hang up to dry

Note: Do not machine wash!
