The 3M™ Speedglas™ Welding Products Guaranteed Trial Order (#GTO) program begins January 1, 2024 and ends on December 31, 2024. No #GTO program claims or returns will be accepted after February 28, 2025.

How to participate in #GTO:



Purchase from 3M Authorized Welding Distributor



Distributor must indicate on the 3M order notes: #GTO, End User Name, State, Zip Code



Begin the 60-day evaluation

To be eligible for participation in this #GTO program, the following conditions must be met:

- The product must be purchased from a 3M authorized welding distributor and used in the United States.
- The end user must register for the GTO program at 3M.com/GTO no later than 15 days from order placement.
- At the time of order placement, the distributor must specify the following code in the customer notes section on the purchase order: “#GTO”
- At the time of order placement, the distributor must indicate the end-user customer on the purchase order.
 - Example of how to designate a #GTO in the customer notes section on an order:
 - § Format: #GTO End User Name, Address, City, State, Zip Code
- Any order submitted without meeting these order entry requirements will be considered a standard order and not eligible for the #GTO program.

To complete a return under this #GTO program, please follow the process below:

1. Within 60 days of the date of purchase, the end-user customer will notify the 3M authorized distributor whom they purchased the 3M™ Speedglas™ GTO Product from, that they wish to return the product.
2. Distributor reaches out to 3M Customer Service by email (3msupport.safety.us@mmm.com) and provides original PO # and material number(s) requested to return for credit.
3. Upon receipt of PO # and material information, 3M Customer Service team will verify #GTO eligibility and send a return goods authorization (RGA) form to the 3M authorized distributor.
4. Distributor should then provide the RGA form to the end user for completion.
5. The end user customer or distributor can then ship all relevant product, **including the completed RGA form**, to the 3M US Returns office.
6. No credit will be issued if all relevant product or RGA form are missing in the return shipment.

If the above and full program terms and conditions are met, then 3M will reimburse the 3M authorized distributor for the order value of the product returned.
