It also holds the Scotch-Brite[™] All Purpose Scouring Pad 9000 for chrome plated grills, and many different Scotch-Brite[™] pads where a long reach is necessary such as cleaning inside fryers.

General Use Directions

Attach a griddle pad to the holder by pressing the pad against the hook side of the holder. The hooks will grab hold on to the pad. Apply desired pressure and scour the surface area in a circular or back and forth motion.

Cleaning Instructions

Dirty griddle pad can be easily detached from the holder, without having to touch the hot and dirty pad, by tapping it into the sink for washing to use again, or into the trash bin if fully used.

Pad holder can be rinsed with warm or hot water or soaked in a cleaning solution to dissolve caked-on soil and grease.

Worn-out pad holder can be disposed of in regular kitchen trash.

Cleaning by Hand

- 1. Wash pad holder in soapy water to remove any remaining soil. Remove embedded soil from it by hand.
- 2. Rinse with clean water and dry it.

Cleaning by Dish Washer

- 1. Spray off or rinse excess soil debris from pad holder using dish sprayer or sink faucet. Remove stubborn soil debris from it by hand.
- 2. Place in dishwasher and make sure it is exposed to washing.
- 3. After washing, take it out of dishwasher and allow to air dry.
