## Packaging

### 3M™ Clean & Shine Daily Floor Enhancer Cleaner Concentrate #35A

- 0.5-gallon bottle - 4 bottles per case

Each 0.5-gallon bottle yields 192 ready-to-use gallons. (Dilution ratio 1:384)

### 3M™ Clean & Shine Daily Floor Enhancer Concentrate #35H

- 0.528-gallon bottle - 6 bottles per case

Each 0.528-gallon bottle yields 202.8 ready-to-use gallons. (Dilution ratio 1:384)

### 3M™ Clean & Shine Daily Floor Enhancer Dosing Bottle

- 32-ounce bottle - 6 bottles per case

Each 32-ounce bottle yields 96 ready-to-use gallons. (Dilution ratio 1:384)

Dilutes at 1 oz (dosing fill line) of chemical per 3 gallons of water

### 3M™ Clean & Shine Daily Floor Enhancer Bulk

- 2.5-gallon container - 2 containers per case

Each 2.5-gallon container yields 960 ready-to-use gallons. (Dilution ratio 1:384).

## General Use Directions

The 3M™ Clean & Shine Daily Floor Enhancer #35 is not intended to be mixed with or used directly with other cleaning chemicals or disinfectants. It is incompatible with other chemistries and we cannot guarantee performance if mixed. Mixing with other chemistries may result in clumping or creation of a sludge. It is critical to flush the unit or reservoir with clean water prior to filling or dispensing the 3M™ Clean & Shine Daily Floor Enhancer #35.

### Autoscrubber or Mop & Bucket

Flush out the autoscrubber or reservoir with fresh water to remove any chemical residue.

### 3M™ Twist 'n Fill™ Chemical Management System and 3M™ Portable Flow Control Dispenser

Prior to using the 3M™ Clean & Shine Daily Floor Enhancer #35H, flush the system with fresh water for at least 10 sec to ensure it is free of previous chemical residue. Dispense 3M™ Clean & Shine Daily Floor Enhancer #35H with cold water using the 3M™ Twist 'n Fill™ Chemical Management System or 3M™ Portable Flow Control Dispenser into a mop bucket or directly into an auto scrubber.

## Product Description

3M™ Clean & Shine Daily Floor Enhancer #35A is a concentrated product to be diluted and dispensed using the 3M™ Flow Control Chemical Management System Wall Mount Dispenser or the 3M™ Flow Control System Portable Dispenser. 3M™ Clean & Shine Daily Floor Enhancer Concentrate #35H is a concentrated product to be diluted and dispensed using the 3M™ Twist 'n Fill™ Cleaning Chemical Management System. Improper use or dilution may result in a decrease in product performance and may increase the risk of health effects. Ready-to-use Clean & Shine Daily Floor Enhancer cleaner is designed to clean hard flooring surfaces.

Daily use may repair surface scratching and improve visual appearance including cleanliness, gloss and distinctness of image (DOI) depending on floor type and condition. When used as part of the 3M™ Advanced Floor Care System in combination with the 3M™ Scotch-Brite™ Clean & Shine Pad and 3M™ Scotchgard™ Protect & Shine Floor Protector, burnishing may be reduced or eliminated.

## Applications

- Coated or un-coated hard floor surfaces including marble, travertine, slate, granite, limestone, ceramic/porcelain, terrazzo, concrete, vinyl composition tiles, sheet vinyl, luxury vinyl tile, rubber, linoleum
- Use with auto scrubber, mop and bucket, or flat mop

**3M™ Flow Control Chemical Management System Wall Mount Dispenser**

Use in a quadrant that has been flushed from other chemicals. Also flush out the main chemical line by running water through the dispenser for at least 10 seconds.

**NOTE: It is important to not use the 3M™ Clean & Shine Daily Floor Enhancer Concentrate #35A in a quadrant that was previously used for dispensing a cleaning chemical or disinfectant that has quaternary ammonium compounds in its formulation.**

Dispense 3M™ Clean & Shine Daily Floor Enhancer Concentrate #35A with cold water using the 3M™ Flow Control Chemical Management System Wall Mount Dispenser or the 3M™ Portable Flow Control Dispenser into a mop bucket or directly into an auto scrubber.

Dispense 3M™ Clean & Shine Daily Floor Enhancer Dosing Bottle from the side-fill cap at the proper dilution ratio after calculating the container volume of either a buddy jug, mop bucket or autoscrubber. Use with cold water.

1. Dust floors using 3M™ Easy Trap™ Duster.
2. Properly position caution signs for wet floor conditions.
3. Mop floor or scrub using an auto scrubber or floor machine with a 3M™ Scotch-Brite™ Clean & Shine Pad or another appropriate cleaning pad.

**NOTE:** For the Dosing and Bulk container, dilutes at 1 oz chemical per 3 gallons of water.

4. Pick up soiled solution with a wet vacuum or tightly wrung mop.
5. No rinsing required.
6. Allow floor to dry. Note: Floors may be slippery when wet.
7. Burnish immediately after cleaning (optional).

**Personal Protective Equipment (PPE) Recommendation: Refer to SDS for specific PPE guidance.**

Waste Disposal Method: Dispose of contents/container in accordance with applicable local/regional/national/international regulations. Rinse empty container with water and recycle (No.2 HDPE).
