## 3M、2020年5月の月間売上情報を報告

当資料は、[3M社（本社：米国ミネソタ州、NYSE:MMM）が2020年6月15日（現地時間）に発表した報道資料](#)を和訳したものです。

5月のまとめ：

- 売上高は前年同期比 20%減の 22 億ドル
- 営業日が昨年の 22 日に対して今年は 20 日と 2 日少ないこと（前年同期比 9%減）が売上高を押し下げる結果に

3Mは2020年5月の月間売上情報を報告しました。

5月の売上高は前年同期比で 20%減少して 22 億ドルでした。既存ビジネス※（Organic local-currency sales：事業売却や買収を除いた既存ビジネス）の現地通貨建ての売上高は、前年同期比で 21%減少し、買収・事業売却による増加が 2%、外貨換算の影響による売上高の減少は前年同期比で 1%でした。

ビジネスグループ別の売上高は、ヘルスケアで 11%、コンシューマーで 12%、セーフティ&インダストリアルで 17%、トランスポーション&エレクトロニクスで 30%減少しました。既存ビジネス※の現地通貨建ての売上高は、コンシューマーで 11%、セーフティ&インダストリアルで 15%、ヘルスケアで 22%、トランスポーション&エレクトロニクスで 28%減少しました。

地域別の売上高は、アジア太平洋地区で 15%、米州で 21%、EMEA（欧州、中東、アフリカ）で 26%減少しました。既存ビジネス※の現地通貨建ての売上高は、アジア太平洋地区で 15%減少（中国では 6%減少、日本では 18%減少）したほか、北米、ラテンアメリカで 24%減少（米国では 22%減少）、EMEA（欧州、中東、アフリカ）で 25%減少しました。

上記の 2020 年 5 月の売上高には、営業日が昨年の 22 日に対して今年は 20 日と 2 日少ないこと（前年同期比 9%減）が影響しています。なお、2020 年 6 月の営業日は 2019 年 6 月よりも 2 日多いので、第 2 四半期に上記のような影響が生じることはないと思込まれます。
