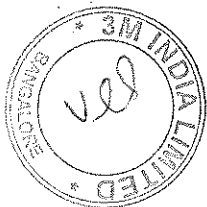

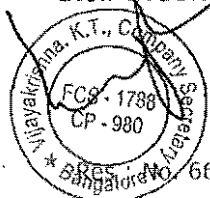

I, Vijayakrishna KT, Company Secretary in Whole-Time Practice (FCS No 1788, CP No.980), having office at # 496/4, 2<sup>nd</sup> Floor, 10<sup>th</sup> Cross, Near Bashyam Circle, Sadashivanagar, Bangalore – 560 080, was duly appointed as Scrutinizer by the Company for the purpose of scrutinizing the Postal Ballot facility provided as per Sections 108 and 110 of the Companies Act, 2013 ('the Act'), read with Rule 20 and 22 of the Companies (Management & Administration) Rules, 2014 as amended from time to time ('the Rules') and the provisions of Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

My responsibility as a Scrutinizer is to ensure that the voting process is conducted in a fair and transparent manner and is restricted to make a Scrutinizer's Report for the votes casts in "favour" or "against" on the Resolution proposed in the Notice dated 21<sup>st</sup> June, 2018 based on the report provided by Karvy Computershare Private Limited, the Agency engaged by the Company to provide e-voting facility and ballots received through post up to 26<sup>th</sup> July, 2018.

In terms of the aforesaid Notice and as per the provisions of the Act and the Rules, e-voting was kept open from 27<sup>th</sup> June, 2018 (9.00 A.M. IST) till 26<sup>th</sup> July, 2018 (5.00 P.M. IST) and Members were requested to cast their votes electronically conveying their assent or dissent in respect of the Resolution on the e-voting platform.



The details containing *inter-alia*, the list of the Members, who voted "for" or "against" on the Resolution that was put to vote, was derived from the Ballots received and the report generated from the e-voting website of Karvy Computershare Private Limited i.e. [www.evotingin.karvy.com](http://www.evotingin.karvy.com) and based on such reports,

- a. 81 members have cast their votes through remote e-voting.
- b. 56 members have cast their votes through Physical Ballot.

On verification of 137 Ballots received by post and voting through e-Voting, up to 26<sup>th</sup> July, 2018 from the Shareholders of 3M India Limited, holding Equity Shares, both in physical and electronic mode, and based on the information made available to me, I hereby submit my Report on the results of the Postal Ballot, as follows:

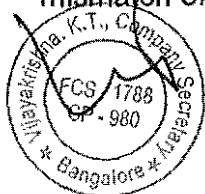


The Promoters being considered as 'Related Parties' for the subject Resolution under the provisions of the Companies Act, 2013, have abstained from exercising the voting rights.

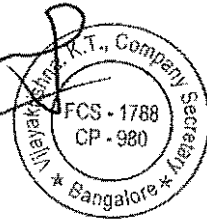


