Graphics applied to floor and covered by 4+ layers of acrylic floor finish

- Scrub daily. Use a 3M™ Red Buffer Pad 5100 or Scotch-Brite™ Clean & Shine Pad on an autoscrubber with a neutral cleaner. A mop and bucket with a neutral cleaner can be used in areas not maintained with an autoscrubber.
- High-speed burnish. Use an appropriate burnish pad for the acrylic finish.
- Scrub and recoat. Wet scrub using a Scotch-Brite™ Surface Preparation Pad Plus and water. Apply 2+ coats of acrylic finish.
- Strip and recoat. Remove the current floor graphic during stripping process when possible. Use appropriate floor stripper with stripping pad to remove old finish. Clean floor thoroughly with neutral cleaner. Apply new floor graphic. Coat with 4+ layers of acrylic floor finish.

Graphics applied on top of floor coatings or uncoated floor surface

- Scrub daily. Use a 3M™ Red Buffer Pad 5100 or Scotch-Brite™ Clean & Shine Pad on an autoscrubber with a neutral cleaner. A mop and bucket with a neutral cleaner can be used in areas not maintained with an autoscrubber.
- Do not high-speed burnish. If high-speed burnish is necessary, remove the floor graphic, burnish floor, and apply a new floor graphic.
- Scrub and recoat (acrylic floor finishes). Remove the current floor graphic. Wet scrub using a Scotch-Brite™ Surface Preparation Pad Plus and water. Apply desired number of coats of floor coating. Apply a new floor graphic after floor coating has cured.
- Strip and recoat (acrylic floor finishes). Remove the current floor graphic. Use appropriate floor stripper with stripping pad to remove old finish. Clean floor thoroughly with neutral cleaner. Apply new floor graphic. Coat with 4+ layers of acrylic floor finish.
- Scrub and recoat of surfaces coated with Scotchgard™ Stone Floor Protector or Scotchgard™ Resilient Floor Protector. Remove the current floor graphic. Wet scrub using a Scotch-Brite™ Purple Diamond Pad Plus and water. Apply one or two coats of Protector. Apply a new floor graphic after Protector has cured.
- Re-polish of stone, concrete, or terrazzo. Remove the current floor graphic. Remove floor coating. Use appropriate sequence of diamond
 abrasives to refine floor. Apply desired sealer, protector, or coating. Apply a new floor graphic.
