Take Advantage of a Tax-Advantaged Account

A Health Reimbursement Arrangement (HRA) is a powerful tool for your health, helping you pay for qualified medical expenses that you would otherwise be paying out of pocket.

If you are eligible for a Non-Medicare Eligible HRA or Medicare Eligible HRA, here are some things you should know.

Premium automatic reimbursement

You can use HRA funds to reimburse yourself for eligible medical expenses, including the premiums you pay for medical coverage.

• Set up the Premium Auto-Reimbursement feature for automatic reimbursement of your monthly premiums.

Direct deposit

Enroll in the Your Spending Account[™] direct deposit program for reimbursements of approved claims electronically deposited into your checking or savings account.

To set up a premium for automatic reimbursement and/or direct deposit, go to Your Spending Account through Your Benefits Rewards[™] at <u>digital.alight.com/3M</u> or contact 3M FIRST Line Center at 888-611-5500.

• Once set up, no action is needed.



Notice of Privacy Practices

3M group medical plans are required by law to maintain the privacy of your health information and provide you with notice of their legal duties and privacy practices with respect to your health information. You can review a copy of the Notice of Privacy Practices on go.3M.com/retirees.

Protect Your 3M Retirement Account with Mobile Text Alerts

At 3M, we take the security of your retirement account very seriously. To help us protect your account, we strongly encourage you to enroll in mobile text alerts. These alerts ensure that you are immediately notified of:

- Financial transactions on your account
- Changes to your personal information
- Changes to your bank or financial institution information
- Other security alerts related to your benefits account

Take action

- 1. Make sure you have a mobile number on file that can accept text messages.
- Access the Your Benefits Rewards[™] website at digital.alight.com/3M.
- 3. Enter Username and Password and click "Log On."
- 4. Click "Your Profile" in the upper right corner and select "Manage Communications."
- 5. Click the Change button next to "Text" under the Preferred Contact Information section.
- 6. Scroll down to Mobile and add/update your mobile number.
- 7. Click "Save."

Opt into text messaging

- 1. Access the Your Benefits Rewards[™] website at digital.alight.com/3M.
- 2. Enter Username and Password and click "Log On."
- 3. Click "Your Profile" in the upper right corner and select "Manage Communications."
- 4. Scroll down to the Delivery Preference section and click the Change button next to "Text Messages for Benefits."
- 5. Check the box next to "Yes" and click "Save and Return."

Reminder: 3M Volunteer Match

When you volunteer at least 25 hours in a calendar year at one eligible nonprofit, the 3M Foundation will provide a \$500 grant to that same organization. Most U.S. schools and public charities qualify. Match requests for 2020 hours are due Dec. 31, 2020.

How to log hours and request your match:

- 1. Visit 3Mgives.com/match.
- 2. Click on "Login-Outside 3M Network."
- 3. Enter your Employee ID (01xxxxx) and password; if you are a first-time user, click "Create your password."
- 4. Click "I Accept" to enter the 3Mgives Community Engagement Portal.
- 5. Click "Volunteer."
- 6. Click "Log Hours/View History."
- 7. Click "Log Hours" to search for your organization and submit your time.
- 8. Once you have logged 25 hours with one organization, the "Request Match" box will be available for you to click and submit your 3M Volunteer Match request.

Year-End Tax Reminders and Tips

With the tax year-end fast approaching, it is a great time to review these reminders and tips for the upcoming tax season.



W-2s

If you received 3M taxable wages in 2020 (e.g., exercised a stock option or received AIP/sales compensation), your W-2 will be mailed to the most recent address 3M has on file no later than Jan. 31.

- If you need to update your mailing address, go to Your Benefits Rewards[™] at digital.alight.com/3M or contact 3M FIRST Line Center at 888-611-5500.
- You may also receive a 1095-C form, showing that you and your dependent(s) were offered and enrolled in medical coverage in 2020.

General Employee Stock Purchase Plan

If you sold stock purchased through the 3M General Employee Stock Purchase Plan (GESPP) in 2020, you may experience what the Internal Revenue Service (IRS) calls a "disqualifying disposition." A disqualifying disposition is when shares are sold within two years of purchase.

- When this happens, 3M is required to report the difference between the fair market value at purchase and your option price as compensation on your W-2 in the year of disposition.
- In addition, you will need to report any gains or losses on your tax return.
