

PRODUCT LABELING NOTICE

3M™ PROTECTA® Rebel™ Self Retracting Web Lifeline CSA Market Only

3M Fall Protection has identified a labeling error with a limited number of 3M™ PROTECTA® Rebel™ Self Retracting Web Lifelines for the CSA Market only. There have been no reports of injuries or accidents associated with this issue. Between the manufacture dates of May 2020 to Sept. 2020 a limited number of model numbers were mistakenly labeled complying with the 2017 edition of the CSA Z259.2.2 standard (marked as CSA Z259.2.2-17 and should have been labeled as being in compliance with the 1998 edition of the standard (marked as CSA Z259.2.2). All products produced before May 2020 and after Sept. 2020 are properly labeled. This labeling error does not impact the ability of these SRLs to arrest a fall and does not pose a safety issue.

End Users: If this notice of a labeling error is of concern to you, please inspect your 3M™ PROTECTA® Rebel™ Self Retracting Web Lifeline (see photographs to right) to confirm that it is one of the model numbers listed above and has been manufactured between 2020 May and 2020 Sept. (20/May to 20/Sept.). Once you have confirmed the model number & manufactured date, if the label states compliance to CSA Z259.2.2, the SRL has been properly identified. If the label states compliance to CSA Z259.2.2-17, the SRL is labeled incorrectly and you should contact Customer Service at [1-833-998-2243](tel:1-833-998-2243) or at 3mcafpserviceaction@mmm.com and we will arrange to have the SRL returned to 3M Fall Protection. Returned product must pass a pre-use inspection. If it passes the inspection, we will replace the label on your 3M™ PROTECTA® Rebel™ Self Retracting Web Lifeline referencing the CSA Z259.2.2 standard. If it fails inspection, we will dispose of the SRL and contact you.
