

**SCOTCH-BRITE™ BRAND SPRING CLEANING SWEEPSTAKES  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

**SWEEPSTAKES PERIOD:** The Scotch-Brite™ Brand Spring Cleaning Sweepstakes (the “Sweepstakes”) begins at 12:00:00 a.m. Central Time (“CT”) on April 9, 2021 and ends at 11:59:59 p.m. CT on April 30, 2021 (“Sweepstakes Period”).

**SPONSOR:** Scotch-Brite™ Brand, 3M Company, 3M Center, St. Paul, MN 55144 (the “Sponsor”).

**ELIGIBILITY:** The Sweepstakes is only open to legal residents of the 50 United States and the District of Columbia who are at least 18 years old (except residents of AL and NE who must be at least 19 years old and residents of MS who must be at least 21 years old) at the time of entry.
