

#### Terms & Conditions:

1. The Competition will commence on 1/3/23 and finish on 31/8/23 at 5pm AEST ("Competition Period").
2. Entry is open to Australia & New Zealand Residents over the age of 18 years who purchase and redeem a specially marked bucket of 3M 982CX Fibre Discs during the Competition Period ("Entrants").
