

Barrier face coverings are primarily intended as a means of source control for minimizing the projection of expelled materials from the wearer's nose and mouth.

- When used as instructed, this product can help to filter certain airborne particles from the air that flow through the filter material. Use cannot eliminate the inhalation of contaminates, nor will it eliminate the risk of disease, illness, or death. Use For:

- The 3M™ Filtering Barrier Face Covering is a single use, barrier face covering designed to cover the mouth and nose as a means of source control for minimizing the projection of expelled materials from the wearer's nose and mouth. It is held in place using the elastic side bands secured using the hook attachment behind the base of the head.
- 2. This product has been tested by a third party per ASTM F3502-21, Standard Specification for Barrier Face Coverings, and shown to offer a degree of particulate filtration. Sub-micron particulate filtration efficiency and airflow resistance do not account for leakage of air around the perimeter of the barrier face covering. Air leakage can significantly affect overall product filtration efficiency.

Do Not Use For:

- 1. This product is not a NIOSH approved respirator. It does not provide respiratory protection. Do not use in an environment where respiratory protection is needed.
- 2. Not for use in any surgical setting or where significant exposure to liquid, bodily or other hazardous fluids may be expected; not for use in a clinical setting where the infection risk level through inhalation exposure is high. 3. Not to be used by children.
- 4. This product does not supply oxygen, therefore do not use in oxygen deficient environments.
- 5. Do not use in the presence of a high-intensity heat source or flammable gas.

User Instruction and Use Limitation:

- 1. This product is designed for consumer use. If to be used in a workplace, consult supervisor so applicable local regulations can be followed.
- 2. Follow all government guidance and requirements applicable for barrier face coverings.
- Before use, user should read and understand product use instructions, making sure the product is in good 3 condition, suitable for the application and is snug to the user's face. (See packaging for "How to Use" wear instructions.)
- 4. Product is not to be used with facial hair, piercings, jewelry, clothing, or anything on the face that prevents the face covering from touching the user's skin.

- 5. Each time the product is worn the user must check for proper positioning on the face in accordance with "How to Use" wear instructions on packaging or below
- 6. CHOKING HAZARD Small parts. Keep away from children and pets.
- Wearing a barrier face covering may cause breathing resistance. People with some cardiac and lung 7. conditions/diseases (including but not limited to asthma, heart conditions, or respiratory conditions) may not be suited for face covering use. If wearer has any questions about whether it is safe for them to use this product, they should check with their health care provider.
- 8. Use the product in accordance with all user instruction and warning information listed on the packaging and these User Instructions. Air leakage can significantly affect overall product filtration efficiency.
- 9. If dizziness, allergy, or other symptoms of discomfort exist, stop using the product.
- 10.Do not reuse, launder, clean or disinfect.


11. When product is found to be damaged, deformed, dirty or difficult to breathe through, please discard in an appropriate receptacle and replace with a new one.

Storage and Shelf Life:

- 2. Please keep unused product in its original package, store it away from dirt, dust, direct sun light exposure, high temperature/humidity and chemical environments.
- The shelf life of unused product is 5 years from the manufacture date when it is stored in temperature 3 between -4F and 86F and humidity not over 80%RH. The manufacture date can be found on the package.
