

**SCOTCH-BRITE™ BRAND x THE CLEANING LADY SWEEPSTAKES
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

SWEEPSTAKES PERIOD: The Scotch-Brite™ Brand x The Cleaning Lady Sweepstakes (the “Sweepstakes”) begins at 9:00:00 a.m. Central Time (“CT”) on September 16, 2022 and ends at 11:59:59 p.m. CT on September 19, 2022 (“Sweepstakes Period”).

SPONSOR: Scotch-Brite™ Brand, 3M Company, 3M Center, St. Paul, MN 55144 (the “Sponsor”).

ELIGIBILITY: The Sweepstakes is only open to legal residents of the 50 United States and the District of Columbia who are at least 18 years old (except residents of AL and NE who must be at least 19 years old and residents of MS who must be at least 21 years old) at the time of entry (“Entrant”). Void where prohibited or restricted by law.
