## Ceramic Coating Removal Process

1



### Ultrafine Machine Polish

1. Polish the repair area with a 3 in. (7.6 cm) polisher for 30 seconds. Use a 4 in. (10.2 cm) ultrafine foampolishing pad with 3M™ Perfect-It™ EX Ultrafine Machine Polish.
2. Wipe the surface clean with a yellow microfiber cloth.

**Note:** For best results use a process dedicated microfiber cloth.
