General Rules

- Inbound Collect
 - PO # should be numeric and 6-digits. If followed by “000OP” and 3 to 4 additional characters, it is only the first 6-digits that are important
 - Shipments should be invoiced to Purification (as noted above), except if third-party location shown above also services other customers. Check the provided BOL carefully to determine if shipment is billable to Purification
- Outbound Prepaid
 - If BOL # begins with “9G” or “9LD” invoice Healthcare Company/SpinCo (HCSC01)
 - If BOL # begins with anything else invoice Purification.

Most BOL #s will be numeric 8-digits. If in doubt, check BOL to determine correct company to invoice.

- Third-Party
 - Check BOL carefully to determine correct company to invoice
