The conformable acetate backing and Post-it® adhesive in these sheets give excellent long aging characteristics. The matte surface can be written on.

Application Techniques

3M™ ScotchPad™ Repositionable Tape Pad 802 sheets will remove cleanly from most office papers, manila folders, painted wall board, wallpaper, finished woods, metals and plastics, but test the product before using. Avoid applications on lacquered finishes, blackboards, CIBA chrome photographic paper, lexan plastic and leather, because adhesive will shred on these surfaces. Removal is possible with a dry tissue, soft eraser, window cleaner or rubbing alcohol.

Storage and Shelf Life

Store under normal conditions of 4° to 27°C (40° to 80°F) and 40 to 50% relative humidity in the original packaging, out of direct sunlight. For best performance, use this product within 18 months from date of manufacture.
