## **Handling/Application Information**

#### **Directions for Use**

- 1. Apply activator by wipe, brush, or pump spray.
- 2. Allow activator's solvent to evaporate completely.
- 3. Apply cyanoacrylate adhesive within one minute of solvent drying.
- 4. Reapply activator if there is a delay greater than one minute between activator drying and cyanoacrylate dispensing.

#### **Surface Preparation**

Prepare bonding surfaces according to Surface Preparation recommendations for the cyanoacrylate that will be used.

## Storage and Shelf Life

Store under normal conditions of 16° to 27°C (60° to 80°F) and 40 to 60% relative humidity in the original packaging, out of direct sunlight. For best performance, use this product within 12 months from date of manufacture.
