# Handling/Application Information

#### **Directions for Use**

Not recommended for 3M<sup>™</sup> Gasket Makers due to up to 20% loss in strength.

- 1. Ensure parts are clean, dry and free from oil and grease.
- 2. Apply to one or both bonbon surfaces.\*
- 3. Allow parts to dry completely (~30-60 seconds). Activator-coated parts may be held up to their on-part life but surface contamination must be avoided.
- 4. Apply a 3MTM Scotch-Weld™ Anaerobic Adhesive to one or both parts making sure there is sufficient product coverage.
- 5. Assemble immediately, moving surfaces back and forth to ensure full distribution of the adhesive.
- 6. Secure the assembly until fixtured.

\*When using solvents and/or aerosols, extinguish all ignition sources, including pilot lights, and follow the manufacturer's precautions and directions for use.

**Caution:** Never mix adhesives and activator/primer liquids together.

# Storage and Shelf Life

Store under normal conditions of 16° to 27°C (60° to 80°F) in the original, unopened packaging, out of direct sunlight. For best performance, use this product within 21 months from date of manufacture.
