### **Special Considerations**

The extended liner provides a dry edge on both edges of the tape for easy liner removal. Stated product widths include the dry edge of the liner.

- Liner side adhesive: The width of the adhesive on the liner side is narrower than the liner by the amount of the cumulative dry edges.

- Exposed side adhesive: The adhesive on the exposed side is the full width of the product and liner. This helps to establish increased differential in adhesion of the exposed side vs the liner side to further aid in easy removal of the liner.

# Handling/Application Information

#### **Application Techniques**

• Bond strength is dependent upon the amount of adhesive-to-surface contact developed. Firm application pressure helps develop better adhesive contact and improve bond strength.

• To obtain optimum adhesion, the bonding surfaces must be clean, dry, and well unified. Some typical surface cleaning solvents are isopropyl alcohol and heptane.\*

• Ideal tape application temperature range is 70°F to 100°F (21°C to 38°C). Initial tape application to surfaces at temperatures below 50°F (10°C) is not recommended because the adhesive becomes too firm to adhere readily. However, once properly applied, low temperature holding is generally satisfactory.

\*Note: When using solvents, extinguish all ignition sources, including pilot lights, and follow the manufacturer's precautions and directions for use.
