3M™ PTFE Film Tape 5498 has a film backing with a non-silicone rubber adhesive.

Product Features

- Withstands autoclave cycles for several hours at temperatures up to 350°F (177°C) and 400°F (204°C) exposure for shorter periods.
- Extruded PTFE film tape lies flatter than typical skived PTFE film tapes.
