# Product Description

3M<sup>™</sup> Masking Tape 2308 is a general purpose industrial paint masking tape. For vehicle masking it is designed for less critical paint lines and paper holding. It is also useful for general purpose paint masking, bundling, sealing, and other jobs calling for an easy to use tape. Bake temperature resistance is up to 250°F (121°C) for 30 mintues.

#### Product Features

• Tape has been tested and found to meet the requirements of ASTM D 6123 / D 6123-97. 3M does not test each lot for compliance to this specification.

- Thinner crepe backing creates as lower paint ridge, and resists edge bleed by most industrial paints.
- 3M proprietary solvent free adhesive is designed to hold in place, and to remove more easily than some thicker tapes.
- Unwinds easily and works well in masking paper dispensers.
- Prolonged outdoor exposure may make tape difficult to remove.
