Store under normal conditions of  $16^\circ$  to  $27^\circ$ C ( $60^\circ$  to  $80^\circ$ F) and 40 to 60% relative humidity in the original, unopened packaging, out of direct sunlight. It is important to keep product above  $10^\circ$ C ( $50^\circ$ F) at all times in order to preserve the integrity of the formulation. When shipped or stored below  $10^\circ$ C ( $50^\circ$ F), the product may foam during use. For best performance, use this product within 21 months from date of manufacture.
