

## **Product Advisory Notice**

Dear Valued Customer,

We are notifying our customers in the UK about an update to protection factors stated on the packaging of the 3M<sup>™</sup> Maintenance Free Reusable Respirator 4000+ Series models:

This change does not affect the protection offered by these products because the product design and manufacturing process is not changing.

The quality and the efficiency of all facepieces is unchanged and they continue to meet EN405:2001 + A1:2009 and a historical particulate protection factor of 50.

The aim of this packaging update is to align the 3M<sup>™</sup> Maintenance Free Reusable Respirator 4000+ Series **particulate** protection factors stated on the packaging to the UK Assigned Protection Factors (APFs) stated in the EN 529: 2005 Guidance Document. Equivalent APFs are also used in Ireland. The APF stated on the packaging for **particulate** protection was 20 and is now being updated to 10. The APF stated on the packaging for **gas and vapour** protection remains at 10. Sales of the above products have been put on hold until this packaging update is complete. It is anticipated that the above products with updated packaging will enter 3M distribution networks before the end of 2023.
