- Liner is designed for high-speed die cutting and matrix stripping. Not recommended for sheet on press applications.
 The facestock for this construction is extremely pliable and conformable. This makes it ideal for applications where the facestock must conform with the changes

in the substrate. Such properties make this facestock particularly effective in blood bag labeling applications.
