# **Application Description:**

Critical aircraft parts are masked with tape and films for protection against harsh paint stripping chemicals. Paint stripper is applied and allowed to sit and soak for a period of several hours to days. A re-application of stripping chemicals may be required if paint still remains. After processing, tapes are removed, and the plane is further processed for subsequent painting operations.

## **Application Benefits:**

 Chemical stripper exposes bare metal parts that are required for accurate heavy check inspection
