

## SCOTCH-BRITE™ SIDE SWEEPSTAKES

### OFFICIAL RULES

- 1. SWEEPSTAKES PERIOD:** The Scotch-Brite™ Side Sweepstakes (the “Sweepstakes”) begins at 12:01:00 a.m. Central Time (“CT”) on September 23, 2024 and ends at 11:59:59 p.m. CT on October 31, 2024 (“Sweepstakes Period”).
- 2. SPONSOR:** Scotch-Brite™ Brand, 3M Company, 3M Center, St. Paul, MN 55144 (the “Sponsor”).
- 3. ELIGIBILITY:** The Sweepstakes is only open to legal residents of the fifty (50) United States and the District of Columbia who are at least 18 years old (except residents of AL and NE who must be at least 19 years old and residents of MS who must be at least 21 years old) at the time of entry. Void where prohibited or restricted by law.
