- More efficient cleanup of liner residue

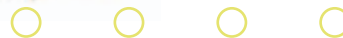
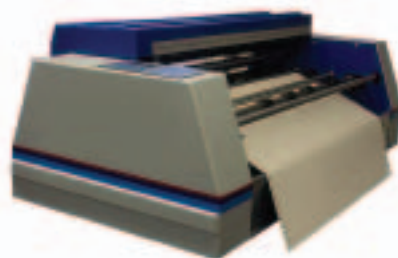
