Products: Select Roller Adjuster

3M is issuing this **"Stop Use & Inspect"** notice for select 3M[™] DBI-SALA® Cynch-Lok Wood Pole Fall Restriction




As part of 3M's ongoing commitment to delivering high quality products, we are notifying our customers of the following information related to an issue related to the orientation of the roller adjusters. The potentially affected materials were produced between June 1, 2024 and October 11, 2024. **3M has determined that in the event of a fall and under certain conditions, these devices may not hold the load as expected which could expose the worker to serious injury.** There are no current reports of injuries or accidents related to these materials.

Due to this, we are sending out this Stop Use and Inspect Notice. Any affected products should be removed from service immediately so the inspection can be performed. Failure to read and follow all instructions associated with this Notice may result in serious injury of a user. Instructions for appropriate next steps are below, see the appendix for a complete list of models impacted by this stop use/inspect notice.

End Users:

Step 1: Find and inspect the roller adjuster attached to the webbing when the product is oriented as shown below. If the roller is facing towards the termination end, then the product is not affected. If the roller is facing away from the termination end, then the product is affected. Proceed to Step 2.



Check the orientation of the roller adjuster relative to the lanyard's termination end.

Step 2: Contact your distributor to return your product for credit at 3M's expense.
