

# **CNY 2026 Nationwide Consumer Promotion**

## **Terms & Conditions:**

Participation in this Promotion constitutes full acceptance of the Terms and Conditions set out below.

## **General terms:**

- To be eligible to participate in the Promotion,

- the Participant must purchase a minimum of \$18 worth of Eligible Products in a single transaction either in store or online from an Eligible Retailer during the Promotion Period (“Entry”).
