

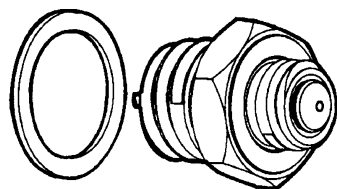

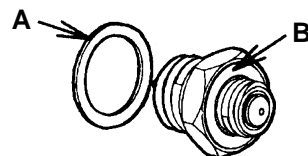

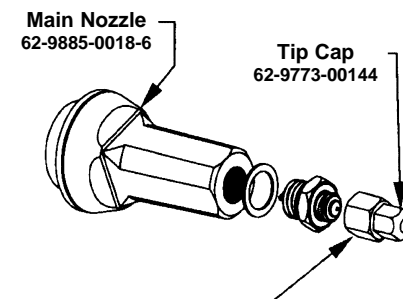
IMPORTANT!



This valve is provided with white, plastic washer (A) and seal (B) to reduce adhesive curing in nozzle during shutdown. The seal and washer are soft and could be damaged by overtightening. Secure valve and tip firmly, but **do not overtighten.**

If the washer (A) is misplaced or damaged, one extra washer is provided with this part.
