As of November 15, 2007, 3M will no longer be offering CFII product plated with SnPb tails. We will continue to offer our fully RoHS compliant* product and the compliant product will become our exclusive offering. Last time purchases need to be placed with 3M by the November 15th date.

Please notify your customers and have them make this change as rapidly as possible in order to minimize production disruption.

- Last time buy orders will not be accepted later than November 15, 2007

A: Dimensionally, yes. The body molding and product design is the same. Only changes in materials were made to eliminate lead from the contact plating.
