Description

3M™ 3-in-1 Floor Cleaner Concentrate 24A is a concentrated product to be diluted and dispensed using the 3M™ Flow Control System Wall Mount Dispenser or the 3M™ Flow Control System Portable Dispenser.

3M™ 3-in-1 Floor Cleaner Concentrate 24H is a concentrated product to be diluted and dispensed using the 3M™ Twist 'n Fill™ Cleaning Chemical Management System.

Ready-to-use 3-in-1 floor cleaner is a neutral floor cleaner designed especially for use in auto scrubbers, and can be used with a mop and bucket.

- 0.5-gallon- bottle
- 4 bottles per case

Each 0.5-gallon bottle typically yields 132 ready-to-use gallons. (Dilution ratio 1:270.)

3M™ 3-in-1 Floor Cleaner Concentrate 24H

- 0.528 gallon bottle
- 6 bottles per case

Each 0.528 gallon bottle typically yields 137 ready-to-use gallons. (Dilution ratio 1:258.)

General Use Directions

Dispense 3M™ 3-in-1 Floor Cleaner Concentrate 24A with cold water using the 3M™ Flow Control System Wall Mount Dispenser or the 3M™ Flow Control System Portable Dispenser.

Dispense 3M™ 3-in-1 Floor Cleaner Concentrate 24H with cold water using the 3M™ Twist 'n Fill™ Cleaning Chemical Management System.

Routine Cleaning:

1. Sweep or dust mop floors using 3M™ Easy Trap Duster.
2. Properly position caution signs for wet floor conditions.
3. Select a 3M™ TopLine Autoscrubber Pad 5000 or 3M™ Red Buffer Pad 5100 for routine cleaning.
4. Run scrubber over floor.
5. No rinse is required.
6. Allow floor to dry.
7. Floors may be buffed or burnished immediately after cleaning.

Deep Scrub Before Re-coating Floors:

1. Sweep or dust mop floors using 3M™ Easy Trap Duster.
2. Properly position caution signs for wet floor conditions.
3. Select a 3M™ Blue Cleaner Pad 5300 or 3M™ Brown Stripper Pad 7100.
4. Run scrubber over floor.
5. Allow floor to dry completely.
6. Burnish floor (optional).
7. Dust floor using 3M™ Easy Trap Duster.
8. Apply 1-2 coats of floor finish as recommended by manufacturers guidelines.
