# **General Use Directions**

#### NOTE

Prior to full adoption, test the product's suitability by cleaning a small, inconspicuous area. Note any changes in color or texture, particularly on old tile floors.

#### NOTE

Do NOT use on soft metal and plastic surfaces, painted surfaces, or other surfaces that are easily scratched.

### NOTE

Refer to the 3M<sup>™</sup> TroubleShooter<sup>™</sup> Baseboard Stripper (Aerosol) SDS for personal protective equipment recommendations.

- 1. Shake the can well.
- 2. Hold the can upside down and spray 6 in. to 10 in. (15.2 cm to 25.4 cm) from the application surface. Cover the soiled area with a thin, even coat.
- 3. Immediately wipe off any overspray onto other surfaces.
- 4. Wait three to five minutes (or longer where there is severe buildup).
- 5. Wet-scrub the surface using a 3M<sup>™</sup> Doodlebug<sup>™</sup> Pad Holder 6472 fitted with a 3M<sup>™</sup> Doodlebug<sup>™</sup> Brown Scrub 'n Strip Pad 8541, 3M<sup>™</sup> Doodlebug<sup>™</sup> Hi Pro Pad 8550, or a similar product.
- 6. For uneven surfaces (e.g., grout, brick, or door jambs), use a 3M<sup>™</sup> General Purpose Brush 4020 with a 3M<sup>™</sup> Doodlebug<sup>™</sup> Handblock Pad Holder 6473.
- 7. Rinse the application surface with clean warm water.
