Scotchgard™ Carpet & Upholstery Protector Concentrate is a concentrate, which is easily diluted with warm water. Scotchgard™ Carpet Protector is an important part of the 3M carpet care system.

Special Features

- Carpet protector surrounds the carpet fibers with an invisible barrier to help protect the carpet from soil and spills
- The barrier allows for easier removal of dry soil, which extends the time between restorative carpet cleanings
- Protector is easy to apply during the periodic restorative carpet cleaning process

Applications

- Commercial and residential carpets
- Most carpet fibers (nylon, polyester, olefins, wool & blends)
- Most carpet styles (loop or cut piles)
- Safe for use on stain resistant nylon fibers
- Upholstery

Packaging

Packaged in 1 gallon bottles. 4 bottles per case.

General Use Directions

Carpet

1. Use a 3M™ All Purpose Sprayer (Model AP-1) equipped with spray tip 8004 or a bulk pressurized sprayer to apply the carpet protector.
2. Mix 1 part concentrate to 8 parts warm water (16 ounces per gallon) in the solution tank of the sprayer.
3. The carpet should be thoroughly cleaned and rinsed before applying carpet protector.
4. The protector is applied to damp carpet immediately following the final extraction/rinse.
5. Hold the spray nozzle 12 inches from the carpet and spray the carpet using straight, even, overlapping strokes at a rate of 200 ft² per ready-to-use gallon.
6. For uniform coverage and faster drying use a pile setting brush or rake on the carpet immediately after spraying.
7. Allow the carpet to dry completely before opening the area to foot traffic.

Upholstery

Note: Protector should be used on water washable fabrics only. Check care label or test protector in an inconspicuous area.

1. Use a 3M™ All-Purpose Sprayer (Model AP-1) equipped with
2. Mix 1 part concentrate to 8 parts warm water (16 ounces per gallon) in the solution tank of the sprayer.
3. Spray apply a light even coat of protector.
4. For best results, apply a second light coat of protector.
