Each 0.528-gallon bottle makes 74 ready-to-use gallons (typical yield).

General Use Directions

1. Dispense 3M™ Industrial Degreaser Concentrate 26A with cold water using the 3M™ Flow Control System Dispenser into a properly labeled trigger spray bottle, or into a bucket or autoscrubber.

Dispense 3M™ Industrial Degreaser Concentrate 26H and 26L with cold water using only the 3M™ Twist 'n Fill Cleaning Chemical Management System into a properly labeled trigger spray bottle, or into a bucket or autoscrubber.

2. Apply to surface with sprayer, cloth, sponge, brush, mop or autoscrubber, avoiding overspray on floor finish surfaces.

3. Scrub/wipe as necessary.

4. No rinsing required.

Personal Protective Equipment (PPE) Recommendations: Refer to ready-to-use SDS.

Special Instructions

Test in an inconspicuous area for rubber, vinyl and painted surfaces, and do not use if discoloration occurs.
