Product Description

3M™ Dyneon™ Fluoroelastomer FX 11818 can be compounded using standard water cooled internal mixers or two-roll mills with standard fillers and ingredients utilized in typical fluoroelastomer formulations. The “dry” ingredients should be blended before adding to the masticated gum. For best results, Dyneon FX 11818 should be banded on the mill several minutes prior to adding the blended dry ingredients. Once mixed, the compounded stocks have good scorch resistance and storage stability.

Product Form

FX 11818 is packaged in slab form and is available in a returnable bulk shipping container system for 1,320 lbs (600 kg) of material. The bulk container system is comprised of 48 individual polyethylene bags containing 27.5 lbs (12.5 kg) of product. Smaller quantities are available in 55.1 lb (25.0 kg) boxes.

Safety/Toxicology

Follow recommended handling precautions for use of 3M fluoroelastomers. General handling precautions include: (1) Store and use all 3M fluoroelastomers only in well ventilated areas. (2) Do not smoke in areas contaminated with dust from 3M fluoroelastomers. (3) Avoid eye contact. (4) After handling 3M fluoroelastomers wash any contacted skin with soap and water.

Potential hazards, including evolution of toxic vapors, do exist during compounding or processing under high temperature conditions. Before processing 3M fluoroelastomers, consult the product MSDS (Material Safety Data Sheet) and follow all label directions and handling precautions.
