Outpatient grouping

The 3M Core Grouping Software contains the necessary tables and logic to accurately classify outpatient services and can be licensed with:

- Medicare Ambulatory Payment Classification (APC)
- Medicare Home Health
- TRICARE APC
- 3M™ Enhanced Ambulatory Patient Grouping (EAPG) System

Outpatient editing

The 3M versions of the Medicare Ambulatory Payment Classification (APC) and TRICARE APC groupers include the Medicare/TRICARE Outpatient Code Editor (OCE), National Correct Coding Initiative (NCCI or CCI) edits and Medically Unlikely Edits (MUE). In addition, the 3M version of Medicare APC and TRICARE APC include a robust suite of proprietary edits to identify potential lost revenue, provide clarity to OCE edits and address areas that CMS examines, but which are not addressed in the public domain grouper.

You may also choose to license 3M™ Medical Necessity edits, which include:

- National and Local Coverage Determinations (NCDs and LCDs)
- Supporting ICD diagnostic codes and modifiers
- Other state Medicaid and payer-specific data
- Frequency, age and gender restrictions

The 3M EAPG System provides editing, including NCCI, MUE, and a full suite of edits designed to ensure correct coding & billing, and identify potential lost revenue.

The Medicare Home Health grouper includes the applicable OCE and NCCI edits, and a set of edits specifically designed to ensure correct coding & billing for Home Health claims.

Editors available for other types of outpatient and professional claims include:

- Medicare Renal Dialysis Facilities
- Medicare Professional Claims Editor

Outpatient reimbursement

The software calculates expected reimbursement using predefined logic and a custom rate schedule. You can define the parameters – such as hospital values, statistics files and other reimbursement variables – that will govern payment processing of your patient claims. Outpatient reimbursement schemes that can be licensed include:

The OPCT can be used in combination with the 3M™ Enhanced Ambulatory Patient Grouping (EAPG) System.

The **Professional Claims Editing and Reimbursement** component also provides editing and reimbursement calculation for all types of Medicare professional claims, including physicians and other professionals, ambulance suppliers, independent clinical labs and other entities that bill for services using the CMS-1500 or 837p forms.
