## **Conflict Minerals**

The U.S. SEC excluded conflict minerals in physical tools, machines and indirect equipment which a manufacturer uses to produce a product from that manufacturer's requirements to report under the Conflict Minerals Rule. 77 Fed. Reg. 56273, 56297-98 (Sept. 12, 2012). #### EU REACH
