Conflict Minerals

On August 22, 2012, the Securities and Exchange Commission (SEC) adopted final rules on conflict minerals reporting, pursuant to Section 1502 of the Dodd-Frank Act which requires manufacturers of products containing "conflict minerals" to disclose to the SEC whether those minerals are sourced from the Democratic Republic of Congo (DRC) or adjoining countries. 3M has been participating in the EICC-GeSI Extractives Workgroup, and are incorporating the EICC-GeSI Conflict Minerals Reporting template in existing systems for use with suppliers of materials that may contain conflict minerals covered by the SEC rules. 3M will provide product-specific information once the required supply chain data has been obtained.
