### SDS (US OSHA)

### China RoHS

**CONEG**

**Conflict Minerals**

**EU REACH**

This product is an article, without intended release of a chemical substance, under the Regulation No 1907/2006 of the European Parliament and the Council concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) (refer to REACH, Article 3(3)).
