# **SECTION 7: Handling and storage**

## 7.1. Precautions for safe handling

Do not breathe dust/fume/gas/mist/vapors/spray. Granules are not respirable. Dust generated during handling may contain respirable material. 3M does not recommend material handling methods that could damage the coating or base mineral. In particular, roofing granules should not be conveyed pneumatically, via screw conveyors, or used as a sand blasting media. These uses can cause coating and base mineral attrition which may lead to increased levels of dust generation. Do not get in eyes, on skin, or on clothing. Do not eat, drink or smoke when using this product. Wash thoroughly after handling. Avoid release to the environment. Use personal protective equipment (gloves, respirators, etc.) as required. Solids can generate static electricity charges when transferred and in mixing operations sufficient to be an ignition source.
