SECTION 4: First aid measures

4.1. Description of first aid measures

Inhalation:

6.3. Methods and material for containment and cleaning up

Collect as much of the spilled material as possible. Place in a closed container approved for transportation by appropriate authorities. Clean up residue with water. Seal the container.
